

USIU-APPI Certified Process & Performance Professional (CPPP) Program



PROGRAM DESCRIPTION:

African economies lose billions of dollars annually due to inefficiencies. The resulting financial pressures are in addition to the current global economic weaknesses and falling commodity prices. - **Stay competitive locally and globally** as millions of professionals skilled in process and analytics will be needed in the next 5 years. Certified candidates will be added to APPI consultant network for future assignments



COURSES AND STRUCTURE:

The program runs for 9 weeks (45 days) and candidates are required to complete all 7 courses to become an **APPI Certified Process & Performance Professional (CPPP)**.

The Program start date is 24th of October to 7th December 2016 for the first 7 sessions. The final 2 sessions will be held from 9th January to 20th January 2017.

The courses are based on global best practices and are uniquely customized for the African audience and environment. The program is designed and administered through strong industry-academia partnership between APPI private sector Consultants, The United States International University (USIU - Africa), and a Professor and Subject Matter Expert in Process from University of Toronto, Canada. A certificate of course completion will be issued

upon successful completion of each course.

APPI **Certified Process & Performance Professional (CPPP)**, uniquely certifies your knowledge and validates your capability to implement business process and performance global best practices in the context of Africa cultural, social, political, economic, and business environment. Individuals will:

- LEARN: the principles, techniques and tools for BPM and performance analytics
- DO: an improvement project for either an employer or selected APPI partner organization
- VALIDATE: their knowledge and solutions through employer or organization's feedback
- CERTIFY: based on your employer or organization's evaluation and recommendation

FEES AND PAYMENTS:

- Value: \$1890 per person (**\$500 per person for the pilot training**)
- 50% payable at registration and 50% before the end of 2nd module

SELECTION CRITERIA:

Business process and performance analytics is industry agnostic, which naturally allows our program to have a diverse mix of participants. We look for candidates who reflect a broad range of industry sectors, functions, and backgrounds to enrich the interactive learning experience. We prefer individuals with:

- Masters degrees or bachelor's degree with 2years work experience
- Excellent communication skills (written and oral)
- Aptitude for logical and analytical thinking
- Highly self-motivated, creative and innovative
- Leadership abilities, team player, and change agent
- Emotional intelligence, open minded, willingness to learn

ADMISSION PROCESS:

- Candidates must submit a resume & a one page essay on process improvement to admission@appinstitute.org
- APPI team reviews applicant submissions and contact successful candidates
- Selected applicants will be invited for interviews and further evaluation
- APPI team makes a decision and informs candidates of acceptance via email
